

# Dental Assisting Course w/Optional Externship Allied Health Program

The purpose of the Dental Assisting course is to familiarize students with all areas of administrative and clinical dental assisting, focusing on the responsibilities required to function as an assistant in a dental practice. The course includes hands-on skills training and CPR certification. This course covers the following key areas and topics:

- Introduction to the dental office and history of dentistry and dental assisting.
- Sciences in dentistry.
- Oral health and the prevention of dental disease.
- Infection prevention in dentistry.
- Occupational health & safety.
- Patient information and assessment.
- Foundation of clinical dentistry.
- Radiographic imaging.
- Dental materials.
- Assisting in comprehensive dental care.
- Dental administration and communication skills.

**Tuition:** **\$2,000 (books included)-***This course is a short-term, non-credit program and therefore is not eligible for FAFSA.
