Medical Billing & Coding Program

The Medical Billing & Coding program provides students with essential skills to solve insurance billing problems, manually file claims, complete insurance forms, trace delinquent claims, appeal denied claims, and understand CPT, ICD-10, and HCPCS coding systems. Coursework includes medical terminology, billing processes, third-party reimbursements, and accurate completion of documentation and insurance forms. After obtaining practical experience, students may qualify to sit for national certification exams such as AAPC CPC, COC, AHIMA CCA, and others.

Program Curriculum & Career Overview

- Medical billing and coding professionals maintain medical records, calculate patient charges, review documentation, and ensure accurate coding for insurance reimbursement.
- Common duties include preparing itemized statements, submitting claims, reviewing patient files, and ensuring documentation meets regulatory requirements.
- Instruction includes ICD-10-CM, ICD-10-PCS, CPT, and HCPCS coding systems integrated with medical terminology and anatomy.
- Medical terminology topics include body structure, musculoskeletal, digestive, genitourinary, circulatory, respiratory, nervous, and endocrine systems.
- Regulatory compliance training covers documentation requirements, laws and regulations, patient information release, and fraud prevention.
- Claims processing instruction includes CMS-1500 form completion, insurance submission procedures, and appeals.
- Front-end office duties include insurance eligibility verification, demographic intake, authorizations, referrals, and determining patient balances.
- Students learn patient adjudication processes including aging reports, payment posting, and interpreting remittance advice

Internet Access Requirement

All students must have access to the internet during the course for communication purposes. Texarkana College utilizes Microsoft Teams and other online platforms to share course materials, provide updates, and facilitate communication between instructors and students. Reliable internet access is essential for successful participation in the program. Students are welcome to use the Texarkana College Academic Commons Wi-Fi to meet this requirement.
